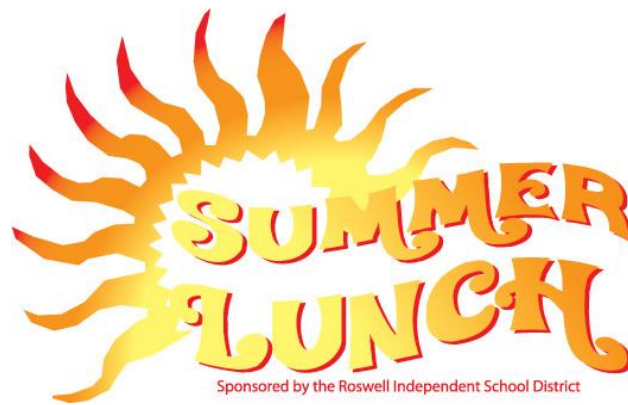

Discrimination Statement: This explains what to do if you believe you have been treated unfairly
